

Privacy Policy

Air Dream College is responsible for the collection and processing of personal data collected through the use of this website. Committing to respect the privacy of users, ensuring the confidentiality and security of the data received, in strict compliance with the legislation in force, namely Law 67/98 of 26 October and Law 41/2004 of 18 August.

This privacy policy describes our practices for handling personal or company information.

Data confidentiality

The user's personal data will not be transmitted to third parties without their prior consent;

None of the user's personal data will be transmitted to direct marketing companies or other entities that use mailing lists to advertise their services and / or products.

Cookies

Google Analytics and Adsense
